

Source Water Protection

Why protect source water?

- Protect Public Health
- Build Community Trust
- Prevent Costs to the Waterworks and the Locality
- Reduce Water Treatment Costs



From Assessment to Protection

SWA = Source Water Assessment


SWPP = Source Water Protection Plan

SWPP Implementation = Putting Protection Plans Into Action



Source Water Assessments


- Updates available from ODW
- Includes:
 - Susceptibility determination
 - Assessment area delineation
 - Potential Sources of Contamination
 - Map
 - Inventory
 - Summary
 - Land Use map

 - Source Water Characterization
 - Protection Goals
 - Action Plan
- Program Implementation
- Evaluation and Revision

- Wellhead Protection Implementation Grants



- Funding information



- Practices for preventing nonpoint source pollution
- Used in the treatment of agricultural and urban stormwater
- Funding Sources:

- Stormwater Local Assistance Fund - DEQ

- ODW contractors may be able to assist in developing public education


